In old business, Clerk presented a contract for brining for \$69,720. Discussion was held and Clerk will request a new contract for 3 single brines instead of 2 singles and a double. When that is received, Clerk and Supervisor will sign and return to the Road Commission. Motion to do so by Cormany, supported by C. Gulembo; carried.

Clerk presented a contract for Larson Rd., select wedging \$134,697.56, and one for 22' wide HMA wedge for \$113,400.00. Motion to sign the contract for 22' wide HMA by Cormany, supported by C. Gulembo; carried.

Motion by M. Gulembo to use West Shore Bank as the depository for all township funds. Motion supported by Borema; carried.

After discussion, it was decided to change the monthly meeting time from 8 p.m. to 7 p.m. Motion by Borema, supported by M. Gulembo to hold monthly meetings at 7 p.m. on the third Tuesday of each month as follows:
