

SHERIDAN TOWNSHIP BOARD MEETING
MINUTES

Minutes of the Regular Meeting, November 21, 2023, held at the Sheridan Township Hall at 7:00 p.m. Present were Corliss Gulembo, Marlynn Gulembo, Jennie Borema, Jeff Cormany, and 10 guests.

Pledge to the Flag.

Minutes of the last meeting were read and approved.

Treasurer's report was given. Motion to approve by Cormany, supported by C. Gulembo; carried.

Clerk reported that the Clerk's and Treasurer's books balance at \$140,344.78, prior to the meeting.

Sheriff Cole presented the October activity report, noting there were 14 calls for service. He reported on the Sheriff's Department budget and recent jail activity.

Commissioner Ron Bacon reported that the County Administrator will begin working with current Administrator Fabian Knizacky in January. Knizacky will stay in his role for another year. The County made \$5,000,000 available for low-income housing.

Assessor Mike Banninga reported that this is the busy season for assessing. A new law was passed giving the assessor the authority to grant or deny 100% disabled veteran's exemptions. It is possible that the December 12 Board of Review will be canceled if no other business comes forward.

Ed Lijewski reported that The Fountain Fire Department has had 207 calls this year, 51 for fire and 156 medical.

Clerk received an authorization from EGLE to Gordon Briggs to proceed with a large quantity water withdrawal in Section 34, Sherman Township.

M. Gulembo made a motion to transfer \$500 from Contingencies to Park. Motion supported by Cormany, and carried.

Discussion was held on discontinuing the portable toilet service at the Cemetery until Spring. Bernie Bovee stated that he will let Steve at Ace-1 know.

Treasurer Jennie Borema presented two resolutions. The first, Resolution to Impose Property Tax Administration Fee, was adopted on a motion by Borema, supported by C. Gulembo, and carried unanimously by roll call vote. Supervisor Corliss Gulembo declared the Resolution adopted. The second, Resolution to Impose 3% Late Penalty on Property Taxes, was adopted on a motion by Borema, supported by Cormany, and carried unanimously by roll call vote. Supervisor Corliss Gulembo declared the Resolution adopted.

Cormany reported on the recent drive-around with the Road Commission. He asked for costs to wedge Griffin Rd. in front of Wertz, wedge or seal Dewey Rd., and pave Morse Rd. north of the bridge, and restructure south of the bridge.

Motion to pay bills, by Cormany, supported by C. Gulembo; carried.

Motion to adjourn by Borema, supported by Gulembo; carried.
