SHERIDAN TOWNSHIP BOARD MEETING MINUTES

Minutes of the Regular Meeting, February 20, 2024, held at the Sheridan Township Hall at 7:00 p.m. Present were Corliss Gulembo, Marlynn Gulembo, Jennie Borema, Jeffery Cormany, and 11 guests.

Pledge to the Flag.

Clerk read minutes of last two meetings and Public Accuracy Test. Hearing no corrections, the minutes were approved.

Treasurer's report was given; motion to approve by Cormany, supported by C. Gulembo; carried.

Clerk reported that the Clerk's and Treasurer's books balance at \$130,076.35, prior to the meeting.

Sheriff Cole reported 13 calls in the Township in December 2023 and 5 in January 2024. He also presented the 2023 activity report for the Township and for the County.

Fountain Fire Chief Ed Lyjewski reported 18 fire calls so far in 2024.

Assessor Mike Banninga presented the Analysis for Equalized Valuation. He also submitted his resignation, effective after the current assessment cycle is ratified by State Equalization in May.

Floyd Kaminski, in conjunction with Dan Quinn, would like to provide a fireworks show on Round Lake on July 5. He is asking permission from the Township. He will get the application form to the Township. Meanwhile, Clerk will check on this with our insurance carrier and MTA.

Bill Chye asked about the markings on Morse Rd. Cormany replied that they are denoting proposed road project. Discussion was held on brining and Cormany relayed information that brining will be allowed, probably only 2 applications of a calcium chloride brine. Mr. Chye also asked about possibly plowing the road to the lake at the Township Park for those wanting to use the lake in the winter. He also asked about a 4x4 in the lake in front of the Schultz property.

Clerk announced that the board is invited to the Mason-Lake Conservation District Dinner.

Clerk presented the Township insurance billing, asking whether we want to include Terrorism coverage at a cost of \$38. Motion to include coverage by Cormany, supported by C. Gulembo; carried

Clerk also presented a request for a \$425 contribution to the Hazardous Household Waste collection program. Motion by Cormany, supported by C. Gulembo to send the requested amount; motion carried.

Discussion was held on salaries for the Township Board. No increase was given to the Township Trustees. Their salary remains \$200/month and \$150/additional meeting. Resolutions to establish salaries for the Supervisor (\$10,000) Clerk (\$15,000), and Treasurer (\$15,000) were offered and approved.
